Liability Waiver

The Revolutionary War Veterans Association ("RWVA®"), a non-profit educational organization dedicated to preserving and protecting the American tradition of practical rifle marksmanship and love of our Revolutionary War history, requires each attendee and/or participant to read, agree to, and sign the following liability release form:

I understand that using firearms can be inherently dangerous and I assume for myself all risk associated therewith. I acknowledge that others also will be using firearms at this event and I will exercise all due caution in my use, and follow all of the safety rules, regarding firearms.

In exchange for being permitted to attend and/or participate in any RWVA® event, including – but not limited to – today's shooting event, **I do hereby release, discharge and agree to hold harmless** the RWVA®, its members, employees, directors, officers, agents, affiliates and volunteers from any and all liability, claims or demands for personal injury, sickness or death, as well as property damages and expenses, of any nature whatsoever which may be incurred by the undersigned, for whom the undersigned assumes full responsibility and liability, that occur while present at any RWVA® event.

Furthermore, I (and for, or on behalf of, the child participant, if said child is a minor or under the age of majority) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in any and all RWVA® events. I also agree to hold harmless and indemnify the RWVA®, its members, employees, directors, officers, agents, affiliates and volunteers for any liability, including all legal and other expenses incurred attendant thereto, sustained by RWVA® or the above referenced individuals as the result of any acts or omissions by myself, regardless of whether such acts or omissions are reckless, negligent or intentional including reasonable attorney fees and costs.

I acknowledge that this liability waiver is intended by the parties to be a complete and unconditional waiver of all potential causes of action that I might be able to bring in any jurisdiction, in either my individual or representative capacity, against the RWVA®, its members, employees, directors, officers, agents, affiliates and volunteers and that this waiver is intended by the parties to be effective for a period of ten years from the date of execution as recited below.

I certify that my presence in the United States of America is lawful and that I am not affiliated with any entity that promotes, supports, or encourages taking up arms against the citizens or government of the United States of America or any other form of armed insurrection. I acknowledge that I am responsible for obeying all local, state and federal laws as they pertain to the firearms that I bring to any RWVA® event and I further certify that I am lawfully permitted to possess and utilize such firearms. I also understand that the RWVA® was formed solely to revitalize America's heritage of rifle marksmanship and to promote America's Revolutionary War history. RWVA® is not a paramilitary organization, does not provide instruction or training for the purposes of causing or furthering a civil disorder, and does not teach or otherwise demonstrate techniques of guerrilla warfare or sabotage.
