Liability Release and Indemnification Agreement

Participation. I am voluntarily participating in activities at Custer Sportsmen's Club that involve firearms. I understand that firearms are hazardous objects that can cause serious injury or death. I agree that I am responsible for my safety while participating in or attending activities at Custer Sportsmen's Club and will take all necessary precautions to avoid injury; I am physically and mentally prepared to safely participate in activities at Custer Sportsmen's Club; I will utilize appropriate safety equipment and obey Custer Sportsmen's Club's instructions and guidelines at all times. I certify that I am not prohibited under any federal or state law from possessing a firearm.

Release and Waiver. I assume all risks, whether known or unknown, foreseen or unforeseen, arising from participating in activities at Custer Sportsmen's Club or being present at the Custer Sportsmen's Club facility. I hereby release, hold harmless and agree to indemnify Custer Sportsmen's Club, its agents, assignees, officers, directors, shareholders, employees, event staff, event volunteers, the owners of Custer Sportsmen's Club and affiliates (collectively, the "Released Parties") from all actions, claims, demands, suits, losses, liabilities, charges, expenses (including, without limitation, attorneys' fees) of any nature whatsoever (including claims for personal, bodily, mental injury and economic loss) that arise from or are in any way related to my participation in activities at Custer Sportsmen's Club or being present at the Custer Sportsmen's Club facility. I execute this release on my own behalf and on behalf of my spouse, partner, guests, heirs, children, legal representatives, and anyone asserting legal rights on my behalf, and this release is intended to relieve the Released parties of any responsibility for any injuries or damage sustained at Custer Sportsmen's Club as a result of my actions. I agree to indemnify and hold Custer Sportsmen's Club harmless to the maximum extent allowed by law for any other loss, liability, claim, damage or expense whatsoever (including legal fees) asserted against or incurred by Custer Sportsmen's Club arising out of my conduct at Custer Sportsmen's Club. I understand that if any portion of this Release is held invalid, I agree that the balance of this Release should continue in full force and effect.

I warrant that that I have the right to execute this Liability Release and Indemnification Agreement in my own name, that I have read the above Release in full prior to its execution, that I am fully familiar with its contents and that I intent to be legally bound hereby.
