Knowing how to shoot is an important requirement for NRA instructors, but you will also need to know how to teach others to shoot. NRA Instructor Training Courses help you develop the additional knowledge, skills and techniques needed to organize and teach courses in the NRA Basic Firearm Training Program.

As such these courses are intended for those that want to teach shooting skills to others. The emphasis is on how to teach—**not** how to shoot.

Class sizes are limited. You are encouraged to register early. If interest in an individual course exceeds class capacity, preference will be given to those individuals working with youth programs such as NRA junior shooting clubs, 4-H programs, Scouting programs, etc.

We are using funds from a Friends of NRA grant to offset a portion of the costs of these courses. Although we will offer other instructor training courses in the future, we cannot guarantee they will be offered at these rates.

NRA Instructor Program

To qualify as an NRA instructor, you must:

- Possess and demonstrate a solid background in firearm safety and shooting skills acquired through previous firearm training (such as completion of an NRA Basic Firearm Training Course) and/or previous shooting experience.
- Satisfactorily complete an NRA Instructor Training Course for the area of specialization you wish to teach (e.g., NRA Basic Pistol Course), and receive the endorsement of the NRA Training Counselor conducting your training.
- Successfully complete the appropriate NRA instructor examination. Certified—90% or higher. Assistant—85% or higher. Apprentice—85% or higher
- Submit your application with appropriate certification fee. Membership in the National Rifle Association is strongly recommended.

A Certified Rating (must be 21 years of age or older) is required to conduct NRA basic courses. An assistant or apprentice instructor may only help conduct courses taught by a certified instructor.

Your responsibilities as an NRA Certified Instructor will include:

- Conducting NRA Basic Courses in accordance with policies and procedures outlined by NRA
- Upholding the quality and integrity of the firearm safety and training standards established by NRA
- Promoting firearm safety and the shooting sports
- Reporting training data to NRA

What is involved?

NRA Instructor Training consists of two parts:

Part One: Basic Instructor Training:

6 hours in length plus prequalification exercises for the Part Two, discipline specific courses
\$30.00 each candidate

Part Two: Discipline specific instructor training:

(14 hours each)
\$40.00 each discipline

Basic Instructor Training (Part One) is a prerequisite to and separate from any of the discipline specific instructor training.

NOTE: The NRA requires that certified instructors who wish to add an additional discipline attend *Basic Instructor Training* unless they have successfully completed *Basic Instructor Training* within one year of this Instructor Training Course. *If it has been over a year since an instructor successfully completed Basic Instructor Training please contact us before registering.*

Discipline specific Instructor training (Part Two)

We will run two separate discipline specific sessions. On March 14-15, we will teach a Basic Rifle Instructor workshop. On March 28-29 we will run a Basic Pistol Instructor workshop—the pistol instructor workshop will also include material for the Home Firearms Safety program.

ATTENDANCE

An instructor candidate must attend *ALL* of the required training hours to satisfactorily complete the course(s) and to receive NRA Training Counselor endorsement for instructor certification.
